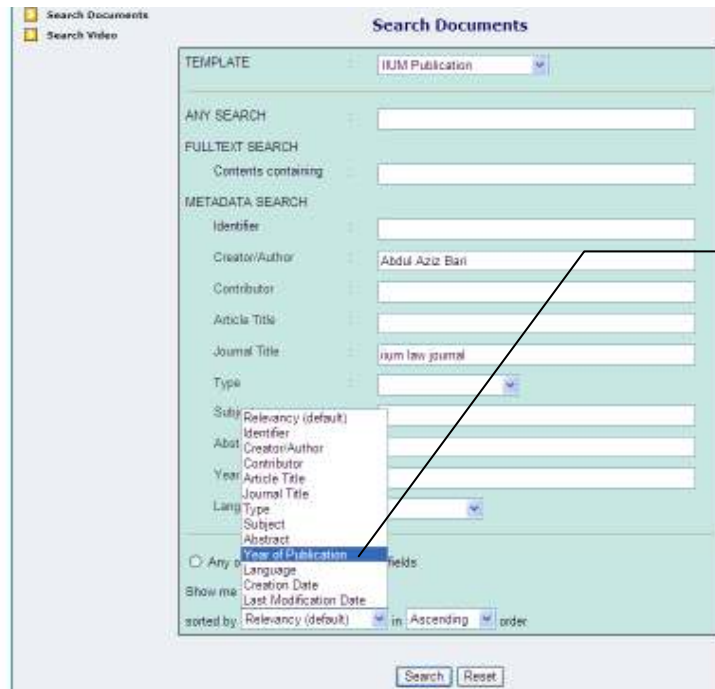

**INTRODUCTION**

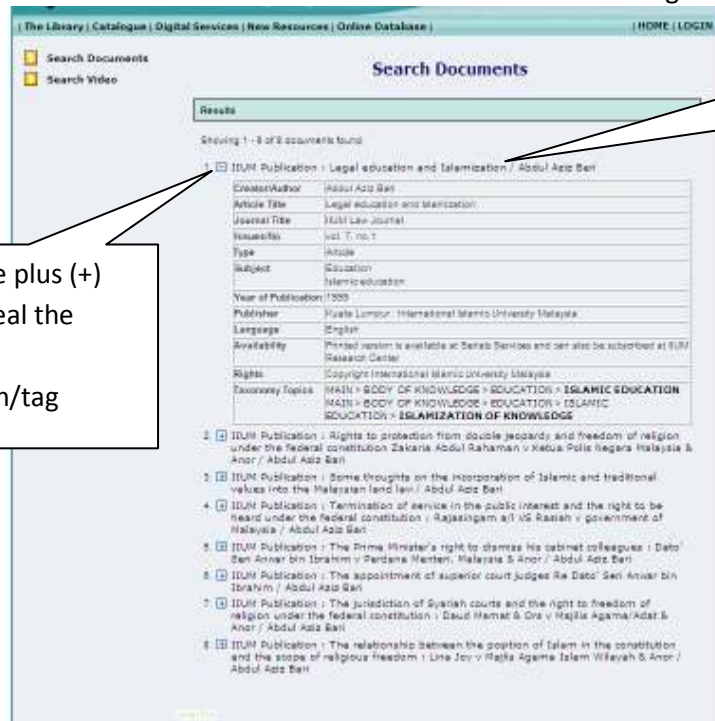
