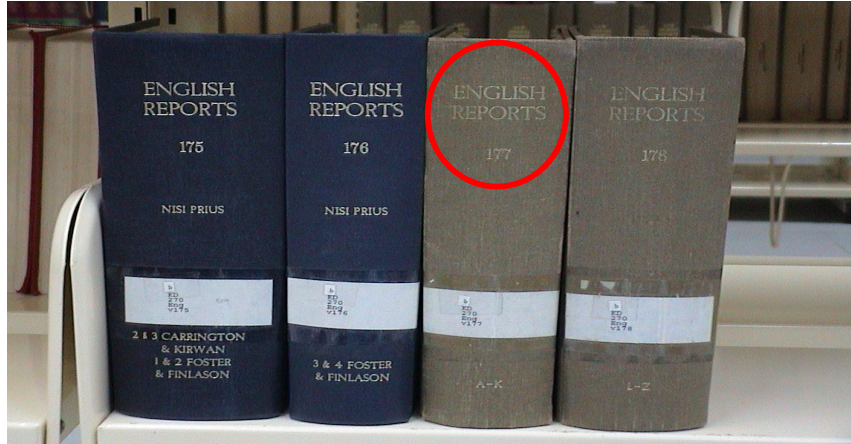




Finding a Case in English Reports: When the Full Citation is Known

The English Reports consist of law cases dated from 1220 to 1865. To start looking for a specific case, for example, **Baxter v. Taylor (1832) 4 B & Ad 72**, follow these easy steps:

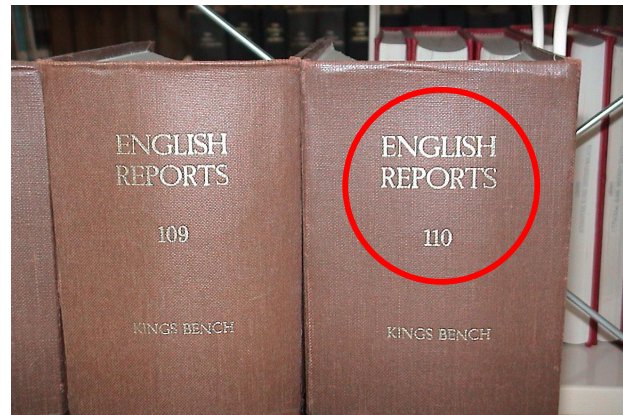
1. Look up in the English Reports' Index, either Volume 177 or 178



2. Identify the Volume and Page No. of the English Reports in Which the Case is Located According to the Names of the Parties
